End User License Agreement for WF-RepTool

SHOULD NEITHER DOWNLOAD, INSTALL NOR USE THE SOFTWARE.

IMPORTANT! READ CAREFULLY: THIS IS A LEGAL AGREEMENT. BY DOWNLOADING, INSTALLING, COPYING, SAVING ON YOUR COMPUTER, OR OTHERWISE USING THE SOFTWARE (AS DEFINED BELOW), YOU (LICENSEE, AS DEFINED BELOW) ARE BECOMING A PARTY TO THIS AGREEMENT AND YOU ARE CONSENTING TO BE BOUND BY ALL THE TERMS AND CONDITIONS OF THIS AGREEMENT.

IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT, YOU

1. PARTIES

- 1.1. "Licensor" means WEEE FORUM, having its principal place of business at Diamant conference and business centre, Auguste Reyerslaan 80, 1030 Brussels, Belgium, registered with company ID 0883.940.313.
- 1.2. "Licensee" means the individual or legal entity specified in the License Certificate. For legal entities, "Licensee" includes any entity which controls, is controlled by, or is under common control with Licensee. For purposes of this definition, "control" means (i) the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise, or (ii) ownership of fifty percent (50%) or more of the outstanding shares or beneficial ownership of such entity.

2. DEFINITIONS

- 2.1. "The Software" means the web-application known as WF-RepTool and relevant background data sources ("WF-RepLists") that have been developed to determine treatment results for WEEE (Waste Electrical and Electronic Equipment), including its documentation, upgrades provided pursuant to Section 8 of this Agreement, and any third party software programs that are owned and licensed pursuant to Section 5 of this Agreement by parties other than Licensor and that either integrated with or made part of the WF-RepTool (collectively, "Third Party Software").
- 2.2. "Authorized User" means (i) if Licensee is an individual, solely Licensee; (ii) if Licensee is a legal entity, any employee, independent contractor or other temporary worker authorized by Licensee to use the Software while performing duties within the scope of their employment or assignment.
- 2.3. "License Certificate" means evidence of a license provided by Licensor to Licensee in electronic or printed form.
- 2.4. "License Key" means a unique key-code that enables Licensee to use the Software at a time. Only Licensor and/or its representatives are permitted to produce License Keys for the Software.

3. OWNERSHIP

- 3.1. Parts of the Software are and will remain the exclusive property of the Licensor. On other parts, the Licensor has obtained a license from the respective right holders ("suppliers").
- 3.2. The Software is licensed, not sold. Title and copyrights to the Software, in whole and in part and all copies thereof, and all modifications, enhancements, derivatives and other alterations of the Software regardless of who made any modifications, if any, are, and will

remain, the sole and exclusive property of the Licensor and its suppliers.

3.3. Further, the structure, organization, code and background data sources embodied in the Software are the valuable and confidential trade secrets of Licensor and its suppliers and are protected by intellectual property laws worldwide, including but not limited to copyright and database rights where applicable.

4. GRANT OF LICENSE

Subject to the terms, conditions, and limitations set forth in this Agreement, including any amendments thereto, Licensor hereby grants to Licensee a limited, non-exclusive, non-transferable and non-sublicensable right to use the Software during the subscription period specified in the appropriate License Certificate as follows:

4.1. Licensee may:

- install the Software on one computer ("Server") and operating system and grant usage to Authorized Users via Internet under one Domain, provided that the number of users never exceeds the number of Authorized Users specified in the appropriate License Certificate and that the same License Key is not used by multiple Authorized Users, on multiple computers, or on different operating systems at a time, and make one back-up copy of the Software solely for archival purposes.
- 4.2. Any other utilisation of the WF-RepTool by the Licensee is only permitted after explicit agreement of the Licensor. Here follows a non-exhaustive list of examples of unauthorized use of the Software:
 sell, redistribute, encumber, give, lend, rent, lease, sublicense, or otherwise transfer the Software, or any portions of the Software, to anyone without the prior written consent of Licensor;
- reverse engineer, decompile, disassemble, modify, translate, make any attempt to discover the source code of the Software, or create derivative works from the Software;
- allow the use of the same License Key on multiple computers, on different operating systems or under multiple domains at a time;
- hand over the background data sources ("WF-RepLists") in their original or translated form to third parties
- hand over the source code of the WF-RepTool to third parties, even if it is in the purpose of further development of the WF-RepTool
- grant access to their WF-RepLists and WF-RepTool installation to other parties

5. BACKGROUND DATA SOURCES

- 5.1. The Licensor has developed and provided the background lists, called "WF-RepLists", for WF-RepTool. A Licensor's consultant shall act as a platform to identify the express need for additional data for the WF-RepLists or any changes made. The Licensee may obtain the updates of the English version of the WF-RepLists free of charge.
- 5.2. The WF-RepTool's native and official language is English and it's strongly recommended to use the WF-RepTool in this native language. If Licensee expresses a desire to have the WF-RepLists and the WF-RepTool surface translated into another language Licensee shall be financially responsible for the costs of translation and for the costs related to the technical work in view of the translation. "Technical work" includes the provision of the basics required for translation.

- 5.3. Licensee shall be financially responsible for translations of updates of the WF-RepLists and the WF-RepTool surface.
- 5.4. All translations have to be done under supervision of Licensor. The translated WF-RepLists and the 'list of menu words' for the WF-RepTool surface and all updates thereafter, if any, shall be provided to the Licensor. In the same ways as the English version of WF-RepLists is property of Licensor all translations are automatically property of Licensor too. Licensor may provide the translations for use to others in any way without notifying translator.
- 5.5. In case of dispute, the English version of WF-RepLists is leading. Licensor has no responsibility for the quality of translations and has no obligation to update translations.

6. THIRD PARTY SOFTWARE LICENSE

- 6.1. Licensee agrees to comply with the terms and conditions contained in Third-Party Software license agreements with respect to the applicable Third-Party Software.
- 6.2. Licensee agrees and acknowledges that Section 10 of this Agreement shall also govern Licensee's use of the Third-Party Software. Licensor will have no responsibility with respect to any Third Party Software, and Licensee will look solely to the licensor(s) of the Third Party Software for any remedy. Licensor claims no right in the Third Party Software, and the same is owned exclusively by the licensor(s) of the Third Party Software.
- 6.3. LICENSOR PROVIDES NO WARRANTY, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE, AND NON-INFRINGEMENT, WITH RESPECT TO ANY THIRD PARTY SOFTWARE.

7. RESTRICTED USE DURING EVALUATION PERIOD

- 7.1. Subject to the terms of this Agreement, Licensee is granted a right to use the Software for evaluation purposes without charge for a period of fifteen (15) days from the date of installation of the Software unless otherwise specified (Evaluation Period).
- 7.2. Licensees use of the Software during Evaluation Period shall be limited to the internal evaluation of the Software for the sole purpose of determining whether the Software meets Licensees requirements and whether Licensee desires to continue using the Software.
- 7.3. Upon expiration of the Evaluation Period, the Licensee must obtain a License Key for use of the Software or cease using the Software. The Software contains a feature that will automatically disable the Software upon expiration of the Evaluation Period. Licensee may not disable, destroy, or remove this feature of the Software, and any attempt to do so will be in violation of this Agreement and will terminate Licensee's rights to use the Software.

8. LICENSE FEES AND PAYMENTS

8.1. Licensee will pay to Licensor the license fee and other charges and expenses as set forth in an appropriate invoice or other purchase documentation. Licensor may charge Licensee interest for any payment that is more than sixty (60) days past due at the rate of two percent (2%) per

month or the highest amount allowed by law, whichever is lower.

8.2. Licence fees are prepaid and are non-refundable. IN CASE OF TERMINATION OF THIS AGREEMENT BY ANY REASON LICENSOR DOES NOT PROVIDE REFUNDS OR CREDITS FOR ANY PARTIAL MONTHS OR YEARS.

9. UPGRADES

- 9.1. All generally available Upgrades to the Software will be free of charge to Licensee during the subscription period mentioned in the appropriate License Certificate. Upon installing any Upgrade, Licensee must cease using a previous version of the Software and destroy the License Key provided by the Licensor for a previous version of the Software.
- 9.2. If not agreed otherwise in writing between Licensor and Licensee, upon upgrading to a new version of the Software the relationship between parties shall be governed and amended (if applicable) by the terms and conditions of the License agreement related to the Software available at [www.wf-reptool.org] on the day of upgrade download or purchase.

10. LIMITED WARRANTY

THE LICENSOR PROVIDES THE SOFTWARE 'AS IS' WITHOUT WARRANTY OF ANY KIND, EITHER EXPLICIT OR IMPLICIT, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE ENTIRE RISK RELATED TO THE QUALITY AND PERFORMANCE OF THE SOFTWARE IS WITH THE LICENSEE. SHOULD THE SOFTWARE PROVE DEFECTIVE, THE LICENSEE ASSUMES THE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION.

IN NO EVENT, UNLESS OTHERWISE AGREED ON IN WRITING, WILL THE LICENSOR, OR ANY OTHER PARTY WHO IS ENTITLED TO MODIFY AND/OR REDISTRIBUTE THE SOFTWARE ON ITS BEHALF, BE LIABLE TO THE LICENSEE OR THIRD PARTIES, SUCH AS TREATMENT PARTNERS OF THE LICENSEE, FOR DAMAGES, INCLUDING ANY GENERAL, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF THE USE OR INABILITY TO USE THE SOFTWARE, INCLUDING BUT NOT LIMITED TO LOSS OF DATA OR DATA BEING RENDERED INACCURATE OR LOSSES SUSTAINED BY THE LICENSEE OR THIRD PARTIES OR A FAILURE OF THE SOFTWARE TO OPERATE WITH ANY OTHER PROGRAMS, EVEN IF THE LICENSOR OR OTHER PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

THEREFORE THE LICENSEE SHALL INDEMNIFY, COVER AND HOLD HARMLESS THE LICENSOR AS WELL AS ANY OTHER PERSON ACTING ON BEHALF OF THE LICENSOR FOR ANY PRETENSIONS, COSTS AND LIABILITY ARISING FROM USE OR ANY OTHER USE OF THE SOFTWARE.

THIS APPLIES TO ANY TYPE OF LIABILITY, IRRESPECTIVE OF THE CAUSE IN LAW.

11. EXPORT REGULATIONS

Licensee agrees and accepts that the Software may be subject to import and export laws of any country, including those of the European Union and United States (specifically the Export Administration Regulations (EAR)). Licensee acknowledges that it is not a citizen, national, or resident of, and is not under control of the governments of any country underlying restrictions arising from applicable import and export laws and is not otherwise a restricted end-user as defined by applicable export control laws. Further, Licensee acknowledges that it will not download or otherwise export or re-export the Software or any related technical data directly or indirectly to the above-mentioned countries or to citizens,

nationals, or residents of those countries, or to any other restricted end user or for any restricted end-use.

12. TERM AND TERMINATION

- 12.1. The license granted herein shall be non-perpetual for the subscription period provided in the appropriate License Certificate.
- 12.2. If the Licensee fails to comply with the terms and conditions of this Agreement, this Agreement and Licensee's right and license to use the Software will terminate immediately.
- 12.3. Licensee may terminate this Agreement at any time by notifying Licensor. Upon the termination of this Agreement, Licensee must cease using the Software and delete the Software from its computers and archives.
- 12.4. LICENSEE AGREES THAT UPON TERMINATION OF THIS AGREEMENT FOR ANY REASON, LICENSOR MAY TAKE ACTIONS SO THAT THE SOFTWARE NO LONGER OPERATES.

13. MARKETING

Licensee agrees to be identified as a customer of Licensor and that Licensor may refer to Licensee by name, logo, trade name and trademark, if applicable, on Licensor's web site, in public or legal documents. Licensee hereby grants Licensor a license to use Licensee's name and any of Licensee's trade names and trademarks solely pursuant to this marketing section.

14. GENERAL

- 14.1. Licensor reserves the right at any time to cease the support of the Software and to alter prices, features, specifications, capabilities, functions, licensing terms, release dates, general availability or other characteristics of the Software.
- 14.2. This Agreement, including the Third Party Software license agreements, constitutes the entire agreement between the parties concerning Licensee's use of the Software, and supersedes any and all prior or contemporaneous oral or written representations, communications, or advertising with respect to the Software. No purchase order, other ordering document or any hand written or typewritten text which purports to modify or supplement the printed text of this Agreement or any schedule will add to or vary the terms of this Agreement unless signed by both Licensee and Licensor.
- 14.3. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach. The provisions of this Agreement which require or contemplate performance after the expiration or termination of this Agreement will be enforceable notwithstanding said expiration or termination.
- 14.4. Titles are inserted for convenience only and will not affect in any way the meaning or interpretation of this Agreement. If any provision of this Agreement is held invalid, the remainder of this Agreement will continue in full force and effect. Either Licensor or Licensee may assign this Agreement in the case of a merger or sale of substantially all of its respective assets to another entity. This Agreement will be binding

upon and will inure to the benefit of the parties, their successors and assigns.

15. ARBITRATION CLAUSE

Any disputes arising out of or in relation with this Agreement shall be finally settled under the CEPANI Rules of Arbitration (www.cepani.be).

The arbitral tribunal shall be composed of one arbitrator. The seat of the arbitration shall be Brussels. The arbitration shall be conducted in the English language. The applicable rules of law are the laws of Belgium, with the exclusion of the Belgian conflict of Laws rules.

The parties further undertake to apply the CEPANI rules of technical expertise for all disputes arising out of or in relation with this Agreement.

"Dispute" means any dispute, controversy or claim arising under, out of or relating to the present Agreement, including, without limitation, its formation, validity, binding effect, interpretation, performance, breach or termination, as well as non-contractual claims.
